A PhD under the All-Ireland Cancer Consortium: The first three years entailed classes in health economics, health policy, epidemiology, implementation science and research training in Ireland at TCD, UCC and RCSI and at The University of North Carolina. At UNC I was involved in comparative effectiveness projects commissioned by AHRQ. In addition I completed the Cancer Control and Prevention Programme in Bethesda, MD and Cost-effectiveness education at York University.

PHD title: Cost-Effectiveness of diagnostics in oesophageal cancer treatment. The thesis consists of three papers, one on the cost-effectiveness of PET/CT in Ireland when treating oesophageal cancer The second paper assessed the cost-effectiveness of restating the cancer after neoadjuvant chemotherapy. The thesis also models the various ways of paying for the cyclotrons and the radio-pharmaceuticals. The final paper examines stage migration and PET/CT in patients with oesophageal cancer. It also looks at the effect PET/CT had on patient selection and treatment pathways.
